



Instructor Agreement

At the 10thGreen.com we believe that our partnership with you and other online instructors is both mutually beneficial and mutually dependent. To make this partnership strong we ask that you agree to the following conditions.

Online Promotion

This agreement is between 10thGreen.com and _____.
As a 10thGreen.com online instructor you permit the 10thGreen.com to display your picture, bio and other information on the website to promote you as an online instructor. 10thGreen.com may also request via email permission to use these materials for website promotion. 10thGreen.com posts this information at no cost to you.

Online Instruction:

10thGreen.com requires a response to all lessons within 48 hours from the time the lesson is sent to your mailbox. Upon receiving a request for swing analysis, you will receive an e-mail alert along with a message alert in your 10th Green mail box. It is our preference that you respond as soon as possible, as we believe promptness adds value to the consumer and credibility to both you and the website. While promptness is a priority, so is quality.

Since the 10thGreen is always available for customers and to ensure a 48 hour turn around time for customers, we've established a way for you to indicate when you are unable to respond to a customer in that time period for any other reason. This can be updated simply by checking the box marked "Unavailable" in the last section of your profile. It is your responsibility to keep your profile up to date with your availability so we can ensure a good customer experience.

You set the price for online lessons based upon the time it takes you to view the video and send feedback to your customer (about 10- 5 minutes) The amount of your commission is equal to the total fee charges, less the amount received by 10thGreen in this transaction (\$2.00), which covers all associated expenses (web hosting, site administration, etc) and small profit margin, less 2.9% + \$.30 Paypal's transaction fee. As an example, If you charge \$15 for a lesson, you would receive \$13 less \$.43 less \$.30 for a net of \$12.27.

All transactions are processed by 10thGreen.com and payment transferred to you through PayPal. It is our goal to have a method of instantly transferring payment once you've submitted your analysis; however at this time due to high cost of implementing that process, we are limited to paying you on the last Friday of each month for all lessons completed that month.

Live Lesson Referral Fee:

As a courtesy we ask for a 10% referral fee for your first live lesson with any student who found you on 10thGreen.com. Payment to the 10thGreen at this time is made through PayPal and is monitored using the non-technical honor system.

Referral Revenue Incentive

For each premium member who signs up using your personal referral code (your login name), you earn monthly or annual referral commission equal to 15% of the premium member subscription. Commissions are paid each month or annually, depending on the frequency of the member's subscription renewal, for as long as the member remains a premium member and/or as long as you maintain an account. This is not a one time fee. With each subscription payment paid by the member you refer, you earn 15% referral commission.

Base on the current membership fees, you receive 15% of the monthly or annual subscription revenue fee that the referred premium member pays to 10thgreen.com. Similar to the online lesson fees, down the road we hope to have these payments automatically transferred to your account. At this time, referral commissions are tracked and recorded in your account history page. These funds are available for withdrawal on the last Friday of the following month the member joined as a premium member. For example, when member signs up on the 15th of October, you are paid the last Friday of November.
